In an effort to keep our office staff, church visitors and community members safe, our office will be closed through April 30th due to COVID-19.



THOUGHTS FROM PHIL

These are challenging days! Churches across our country, and literally around the world, have had to alter our methods of communicating the truths of our Savior due to the pandemic that has taken many lives and threatens many more. We are finding alternative ways of sharing the Good News with people through social media outlets, like Facebook Live, so that we can still gather as the church for worship and Bible study without physically being together. However, without this technology, we would be faced with very limited contact within the body of Christ.

How does the Church of Jesus face such a foe that has secluded us from one another and remain strong and courageous? I'm reminded of the Psalms of David when he was on the run because of the threats against his life. He would write songs to sing to himself that comforted his own heart as he reflected upon the steadfastness of the presence and love of God. Psalm 56 records these words in verses 1 and 2: "Be merciful to me, O God, for mean hotly pursue me; all day long they press their attack. My slanderers pursue me all day long; many are attacking me in their pride." Wow! David had no rest from the mental, emotional, and even physical stress, fearing his life was about to end.

In verses 3 and 4, David continues to reveal his heart of complete trust in the Lord: "When I am afraid, I will trust in you. In God, whose word I praise, in God I trust; I will not be afraid." Again, his refrain states in verses 11 through 13: "In God I trust, I will not be afraid. What can man do to me? I am under vows to you, O God; I will present my thank offerings to you. For you have delivered me from death that I may walk before God in the light of life."

David faced overwhelming fear due to serious, life-threatening foes, yet he stood upon the solid foundation of his faith in God's presence and God's love. We can be like David and demonstrate his strength and courage and place all of our trust upon the Lord Jesus! We will get through this trial with the Lord!

A word from our Executive Director of the TBC, Dr. Randy Davis. He is intending on declaring for the TBC churches a Resurrection Day Celebration sometime in the summer for all of us to celebrate Easter as churches, being we will still be apart on April 12th. We will keep you posted when that will take place.

Churches and non-profits that have individuals on payroll are able to take advantage of the SBA Paycheck Protection Program. Loans will not be required to be paid back as long as you meet the guidelines. This will help struggling churches during this COVID 19 pandemic to cover expenses while still remaining closed. Paycheck Protection Program (PPP)

An SBA loan that helps businesses keep their workforce employed during the Coronavirus (COVID-19) crisis.

Program Overview

The Paycheck Protection Program is a loan designed to provide a direct incentive for small businesses to keep their workers on the payroll. SBA will forgive loans if all employees are kept on the payroll for eight weeks and the money is used for payroll, rent, mortgage interest, or utilities. The Paycheck Protection Program will be available through June 30, 2020.

Who Can Apply

This program is for any small business with less than 500 employees (including sole proprietorships, independent contractors and self-employed persons), private non-profit organization or 501(c)(19) veterans organizations affected by coronavirus/COVID-19.

How to Apply

You can apply through any existing SBA 7(a) lender or through any federally insured depository institution, federally insured credit union, and Farm Credit System institution that is participating. Other regulated lenders will be available to make these loans once they are approved and enrolled in the program. You should consult with your local lender as to whether it is participating in the program. Lenders may begin processing loan applications as soon as April 3, 2020.

Loan Details and Forgiveness

The loan will be fully forgiven if the funds are used for payroll costs, interest on mortgages, rent, and utilities (due to likely high subscription, at least 75% of the forgiven amount must have been used for payroll). Loan payments will also be deferred for six months. No collateral or personal guarantees are required. Neither the government nor lenders will charge small businesses any fees.

Forgiveness is based on the employer maintaining or quickly rehiring employees and maintaining salary levels. Forgiveness will be reduced if full-time headcount declines, or if salaries and wages decrease. This loan has a maturity of 2 years and an interest rate of .5%.
